Course Pre-requisites:

Graduate student in PhD program in the Life Sciences.

Consent of Graduate Advisor (Instructor of record).

Course description: Grant writing exercise on dissertation research or closely related project. Students will derive a hypothesis or primary objective that relates to their dissertation research. The student will develop 2-3 aims and experiments/observations to test this hypothesis or satisfy the objective in a proposal. The proposal should address the potential outcomes of the proposed work, its limitations and alternative experimental or observational strategies. Proposals are required to be at least 6 pages in length.

Learning Outcomes:

As a result of taking this course a student should be able to:

- Derive a hypothesis or primary objective from the primary literature
- Design non-nested aims to test the hypothesis or satisfy the objective
- Devise experiments/observations to address said aims/hypothesis
- Critically analyze the caveats of the proposed experiments/observations
- Develop scientific communication, critical thinking and data analysis skills
- Successfully defend the proposal to their Dissertation Advisory Committee

Course format:

- Ph.D. students write a grant proposal on their research area during a single semester.
- The student is expected to seek input/feedback from their Advisor, Committee, lab mates, and other qualified people on their research project
- The student submits the proposal (ideally in week 11) to allow its evaluation by their graduate advisor and dissertation advisory committee
- The student presents and defends their proposal at a 2-3 h oral defense.
- Grant writing exercise and oral defense is evaluated by the Students Advisor and Dissertation Advisory Committee.

Example timeline:

Assignment begins within the first four weeks of the semester

Student submits written proposal for evaluation by Advisory Committee, April 20th

Student defends proposal in oral defense April 27th 9-11AM (two weeks prior to the end of the semester)

Incomplete Grades—The grade of I—Incomplete—can be granted when a student has satisfactorily completed three-fourths of course work for that semester/session but for reason(s) beyond the student's control, and acceptable to the instructor, cannot complete the last part of the course, and the instructor believes that the student can finish the course without repeating it. The incomplete work must be made up before the end of the following regular semester for undergraduate courses. Graduate students receiving "I" grades in 500-, 600-, or 700-level courses have up to one calendar year to complete the work, at the discretion of the instructor. If course requirements are not completed within the time indicated, a grade of F will be recorded and the GPA will be adjusted accordingly. Students who are fulfilling an Incomplete do not register for the course but make individual arrangements with the instructor who assigned the I grade.
